BISHOP'S MESSAGE FOR JANUARY 2020

Happy New Year 2020 to you all! New Year brings new challenges and opens up new horizons; one makes new resolutions and finds new ways of facing the difficulties of everyday life. May this year provide ample opportunities to find new ways of commitment to the Gospel of Our Lord Jesus Christ in our diocese!

Year of Youth: We have completed 2019 with special focus on the youth and their involvement in the Church's life. We are proud of our young men and women who have done a lot to enhance the quality of parish life. My sincere gratitude to Fr Ronald D'Souza, Fr Ashwin Cardoza, Fr Rupesh Madtha and all the office bearers and Members of ICYM, YCS, Jesus Youth, Youth for Christ, AICUF and all the Priests, Religious and Lay faithful of our diocese.

Follow-Up of the Youth Year: The youth have shown immense amount of social concern and participation in ecclesial

life. They need our support. The Council of Priests has recommended that we launch a fund to support the youth, especially for their growth and development. Therefore, we establish Catholic Youth Welfare Fund. I invite all the priests and religious to motivate the People of God to give generously to build up this fund. The youth should also involve themselves in this drive by strengthening it. The fund will be operated from the Bishop's House. The rules and regulations will be drawn in due course of time.

Two special activities are organized as a continuation of Year of Youth: You-Meet at St Aloysius College for the migrant youth working or studying in Mangaluru on 26 January and an Inter-ritual Youth Convention at Madanthyar Grounds on 2 February 2020. The youth of the dioceses of Belthangady, Puttur and Mangalore are invited to participate to reflect on the youth reality. Catholic Sabha, DCCW and ICYM are jointly organizing it. A separate write-up is in this *Internos* for details. Parish Priests, please announce these activities to the People of God and encourage the youth to participate.

Formation of the Parish Pastoral Council (PPC) Members: The new PPCs are being formed and so also the Finance Councils. Many of the members are new and many Gurkars have newly taken up the mission. Therefore, a training programme is the need of the hour to facilitate them to play their role effectively. The Council of Priests desired that they be trained, keeping in mind the nature and mission of the Church. As it is given in the introduction to the Constitution, the Church is not a democracy, yet She follows democratic principles in many of her activities. The Church is divine and human. She came forth thanks to the divine will of the Father, the Son and the Holy Spirit. The Parish Pastoral Councils and Finance Councils are participatory forms in a synodal Church; they help the Parish Priests and Bishop to strengthen the faith of the people and to witness to the resurrected Christ spreading the Good News of salvation.

The Directory for the Pastoral Ministry of the Bishops, Apostolorum Successores says: "The Bishop should keep clearly in mind that these structures of participation do not take their inspiration from criteria of parliamentary democracy, because they are consultative rather than deliberative. Fruitful dialogue between a Pastor and his faithful will unite them 'a priori in all that is essential, and... [lead] them to pondered agreement in matters open to discussion'. In promoting the participation of the faithful in the life of the Church, the Bishop will recall the rights and duties of governance to which he is personally bound. These include not only witnessing, nurturing and caring for the faith, but also cherishing, defending and proposing it rightly" (n. 165). Keeping this in mind, the directives are given in the Constitution on the Parish Assembly, PPC and Parish Finance Council. Thus, the pastoral and evangelical focus must be kept in mind in all the discussions. A team of priests chosen from the Senate will be the resource persons to train the PPCs. The list is found in this Internos.

Training of the Clergy in the Liturgy according to the New Konkani Missal: The Holy See has already granted permission to print and use the new Missal in Konkani. However, a concerted effort must be made to train the People of God to participate effectively according to the norms of the new Missal. Two days (13 and 14 January) are allotted for the formation of the clergy, both religious and diocesan so that they in turn train the People of God in their respective parishes and religious communities. The participation in this training programme is obligatory. For women religious, a separate training programme will be organized.

Training Programme for the Junior Clergy: On 21 January, a training programme is organized in the Pastoral Institute for the Junior Clergy of 1-10 years of ordination. There are quite a few things that one has to keep in mind to render pastoral and priestly service effectively. The younger Clergy needs to be informed regarding essential documentation. There will be

a moment of interaction in common with the Bishop to share the experiences and deliberate on pastoral problems if any.

Dedication of Year 2020: Human life is the invaluable treasure God has placed on this earth. Every human person is unique and irreplaceable gift of God amid us. Human beings are created in the image and likeness of God and the incarnation of Word of God makes it all the more clear that God. if he wants to become other than himself, he would become man and nothing else. This life has to be respected, protected, conserved and ennobled from its earliest stages of development till its end. We witness tremendous amount of abuse against human life in its most vulnerable phases and situations. The Council of Priests has recommended that we dedicate the year 2020 for creating greater awareness about the preciousness of life. We are the handiwork of God. Indeed, Job prays: "Did you not pour me out like milk and curdle me like cheese? You clothed me with skin and flesh and knit me together with bones and sinews. You have granted me life and steadfast love, and your care has preserved my spirit" (Job 10: 10-12). The Psalmist prays: "you formed my inward parts; you knitted me together in my mother's womb. I praise you, for I am fearfully and wonderfully made. Wonderful are your works; my soul knows it very well" (Ps 139: 13-14).

Keeping these thoughts in mind, we shall dedicate the Year 2020 for creating greater awareness regarding respecting life, protecting it and ennobling it. St Irenaeus wrote: "The glory of God is a living man; and the life of man consists in beholding God" (*Against Heresies*, Book 4, 20:7). Every human being wants to be truly alive and discover ways of living more truly and fully. However, many experience 'alienation' and 'absurdity' because of awareness that there is something essential that is missing in life, something to be looked for beyond or rather in place of the instant 'satisfactions' proposed in today's consumption-oriented societies. We are invited to share in a life that is simply the love God longs to share with all. Let this year bring greater glory to God by our efforts in helping human

beings become fully alive. To help us in this direction, kindly read: "2020 - Year of Life: Respect life, protect it and ennoble it!". I urge the Parish Priests and Heads of Institutions to take up this theme for profound discussions and carry out suitable activities during this year. Wish you once again many blessings of the Lord in this New Year.

2020 - Year of Life: Respect life, protect it and ennoble it!

All of us are concerned about the escalating incidents of suicide, especially, among the young; other than that, there is the hidden industry of abortion which eliminates life in the womb; abuse and ill treatment of children, women and vulnerable adults; young people get addicted to drugs, alcohol etc. Violence and disrespect, using persons only as means to one's own ends are becoming common; less respect is shown towards the elderly and so on. These issues trouble each one of us in one way or other whereupon we are invited earnestly to respond to these challenges posed against the respect for human life. Positively, we also witness growing number of people promoting organ donation (though not considerably), blood donation to those in need, many good Samaritans taking care of elderly in the houses or through palliative care units, some rush immediately to rescue the wounded when there's an accident on the road etc. While, on the one hand, we are worried of the 'use and throw' attitude shown in issues related to human life, on the other hand, we are encouraged, though not powerfully, by those who go out of their way to stand up for life

The Christian tradition believes in God as the one who creates, nourishes, ennobles and finally calls back to him every form of life. Specifically, God is the Creator of life on this earth where human person is the crown of his creation (Gen 1:26).

God, in his loving goodness commences human life at the moment of conception and life on earth ceases to exist at the moment of death. Any intentional intervention in terminating human life before its natural end goes against the unconditional respect due to it (*Donum Vitae* 5, 1). This dichotomy is well formulated by John Paul II as he asserts: "A society lacks solid foundations when, on the one hand, it asserts values such as the dignity of the person, justice and peace, but then, on the other hand, radically acts to the contrary by allowing or tolerating a variety of ways in which human life is devalued and violated, especially where it is weak or marginalized. Only respect for life can be the foundation and guarantee of the most precious and essential goods of society, such as democracy and peace" (*Evangelium Vitae*, 101).

The Christmas celebration that we just celebrated reminded us that Jesus took human form and upheld the precious value of human life in his words and deeds (Luke 4:18). The purpose of his coming is not to condemn us (John 3:16) but to give us life, 'in abundance' (John 10:10). Pope Francis enlarges the discourse to apply it to everything that goes against the principle of protection of human life: "When we fail to acknowledge as part of reality the worth of a poor person, a human embryo, a person with disabilities – to offer just a few examples – it becomes difficult to hear the cry of nature itself; everything is connected (*Laudato Si*', 117).

It is the bounden duty of every individual to uphold the dignity of human person by respecting human life. Therefore, in our diocese it has been decided to declare the year 2020 as "Year of Life" with a special emphasis on human life. The inauguration will take place at Rosario Cathedral on 5 January 2020 during the Diocesan Eucharistic Procession. Hereby I urge the People of God with their ministers to partake in this event and to pledge one's responsibility to protect one's own life and that of others.

DECREE: ENHANCEMENT OF MONTHLY ALLOWANCE AND SLAB OF OUTPATIENT MEDICAL BILLS FOR PRIESTS OF THE DIOCESE OF MANGALORE

1. Monthly Allowance

An old poster states, "Working for the Lord does not pay much, but the retirement plan is out of this world!" The real pay in this life, if you will, that comes for priests, is found in the satisfaction of accompanying God's people in the person of Christ through the dying and risings of life. There is a special benefit that comes in knowing one has helped another like Jesus.

Clerics have necessities of life. Canon law states that "since clerics dedicate themselves to ecclesiastical ministry, they deserve remuneration which is consistent with their condition ... and by which they can provide for the necessities of their life as well for the equitable payment of those whose services they need" (can. 281§1). It continues to state that "clerics are to foster simplicity of life and are to refrain from all things that have a semblance of vanity" (can. 282§1). In other words, they are to embrace simplicity of life and live a humble lifestyle that is not extravagant or ostentatious in any way. The cardinal virtue of prudence plays a pivotal role in guiding the stewardship of a diocesan priest.

The revision of monthly allowance for Priests of the diocese of Mangalore was done in August 2013, and recently, there were suggestions to enhance the amount taking into account the increase in the general cost of living over the past 7 years. The Council of Priests that met on July 12, 2019 accepted the proposal of the Bishop regarding the revised allowance. Now taking into account the various factors that call for at least a nominal increase in the allowance and keeping with the spirit of evangelical counsel of simplicity, I am pleased to decree the following enhanced allowance:

From Ordination till 5 years : Rs 5,500/-From 6 till 15 years : Rs 6,000/-From 16 till 25 years : Rs 6,500/-From 26 and above : Rs 7,000/-Retired Priests : Rs 5,500/- The travel allowance shall be Rs 2000/- for all priests in active ministry, including those who serve in the institutions as well as the teaching clergy.

2. Slab of Outpatient Medical Bills

In the Council of Priests, some of the questions relating to the outpatient bills that can be presented to the Priests' Aid Fund (PAF) were discussed. These concerned the benefits for members under Art. 7(e), (f), and (g). Now considering that there exists a legitimate need to enlarge the existing slab of outpatient medical bills in a year (financial year), I hereby decree the following increase for the benefit of priests:

For an exception regarding any extra or other expenses related to outpatient bills, the permission of the Bishop must be obtained. Only after this, the claim for the amount beyond the established slab is honoured by the PAF.

3. An Increase in the Annual Subscription Fee

A raise in the benefits also brings in an increase in the contribution from the beneficiaries of the Priests' Aid Fund. This helps us to maintain and promote the Fund towards its objectives. Consequently, we direct that individual contribution of Priests to the PAF is raised from Rs 2000/- per annum to Rs 3,000/- per annum.

The decree concerning the enhancement of monthly remuneration, slab of outpatient medical bills, and annual contribution to the PAF comes into effect on April 01, 2020.

By way of conclusion: "The priesthood is a call, not a career; a redefinition of self, not just a new ministry; a way

of life, not a job; a state of being, not just a function; a permanent, lifelong commitment, not a temporary style of service; an identity, not just a role. We are priests; yes, the doing, the ministry, is mighty important, but it flows from the being; we can act as priests, minister as priests, function as priests, serve as priests, preach as priests, because first and foremost we are priests! Being before act! *Agere sequitur esse*, as the Scholastics expressed it. Father William Byron, the former president of The Catholic University of America, is fond of saying that 'we are human beings, not human doings, and our basic dignity and identity comes from who we are, not what we do.' This is true as well of the priesthood" (Timothy Cardinal Dolan).

DIOCESAN CENTRAL POOL OF FUNDS

Preamble

We all believe in the biblical principle of supporting poorer parishes of the diocese. The principle goes as far back as the earliest days of the Church. The apostle Paul took part in at least two collections where churches outside Judea made donations 'for the poor among the saints in Jerusalem' (Romans 15:26; Acts 11:29-30).

There are several ways of one parish helping another parish or parishes. In our diocese, among other means, the diocese of Mangalore has a diocesan fund that reflects the biblical principle of communion and concern. As per Resolution No.10 of the Pastoral Consultation of 1979-1980 and as per the directions given by the Council of Priests these rules and regulations are drawn for the collection and disbursement of a fund called Diocesan Central Pool of Funds (DCPF).

Directive Principles

- (a) A number of Parishes, Mission Stations and Institutions in our Diocese are not self-sufficient and they require outside help for their maintenance and development. In order to help these needy diocesan entities, this fund has been instituted.
- (b) In a spirit of Christian charity and sharing, all the Parishes and Institutions are required to contribute to the Diocesan Central Pool of Funds which will be utilized to assist the above mentioned Parishes, Mission Stations and Institutions.
- (c) Parishes and Institutions which have surplus funds are called upon to contribute to this fund in a spirit of Christian love and generosity.

Objectives

- (a) To foster the spirit of Christian charity and sharing.
- (b) To assist financially the needy and poor Parishes, Mission Stations and Institutions to make them self-sufficient and order parish oriented educational and developmental works.

The Operation of the Diocesan Central Pool of Funds

- 1. The Diocesan Central Pool of Funds will be at the service of the needy institutions and parishes. When the new churches/clergy houses are constructed in rural poor parishes who suffer from the scarcity of funds, the assistance is given from Diocesan Central Pool on priority basis.
- 2. In rural and poor parishes financial assistance is given to the construction/repair of schools/maintenance.
- 3. Financial advance is given to the parishes/institutions for income generating schemes to make the institution/parishes self-reliant. However, once the income is generated, the advance is to be refunded without interest.
- 4. Due to the enhancement of the allowances and T.A. of the Priests, financial assistance is given to the needy Parishes/Institutions.

Collection of Funds

- 1. Every Parish shall contribute from its gross income 3% annually to Diocesan Central Pool of Fund.
- 2. Every hall of Parish or Institution shall contribute 10% of its gross income to Diocesan Central Pool annually.
- 3. The contribution shall be sent to the Procurator of the Diocese, after getting the Review Report on the Parish audited statement by the Vicar General.
- 4. The full amount has to be paid to the Procurator's Office by 31st October of every year.

Management Committee

The management of the fund is vested in a committee of the following members:

- (a) Ex-officio: The Bishop, Vicar General, and Procurator
- (b) Elected: 2 priests from the Council of Priests
- (c) Nominated: 2 Members from the Diocesan Finance Council

Office Bearers

- 1) Bishop will be the ex-officio President.
- 2) Vicar General will be the ex-officio Vice-President.
- 3) Procurator will be the ex-officio Treasurer.
- 4) Secretary Elected from the members
- 5) The term of the elected and nominated members will be as per the term in Council of Priests and Diocesan Finance Council respectively.

Disbursement of the Funds

- 1) The applications are available with the Procurator of the Diocese to be forwarded to the Diocesan Central Pool. The Parishes and Institutions who need funds should apply to Diocesan Central Pool Funds (DCPF) with properly drawn up project including plans, estimates, recurring expenses, economics of the project, feasibility of the project etc.
- 2) The application will be accepted in the month of March and October every year. The Diocesan Central Pool Funds

- (DCPF) committee will scrutinize these applications in the Month April and November respectively.
- 3) The Management Committee will scrutinize and investigate the project either by themselves or through experts and find the projects on priority basis depending on the availability of Funds.
- 4) The project holders are required to maintain books of proper accounts and submit the same after utilization of funds.
- 5) The Management Committee has the right to inspect the execution of the project and scrutinize the accounts and also to make suggestions for improvement.

Conclusion

The DCPF is not merely to offer some financial assistance to poorer parishes, but is also designed to create genuine fellowship among parishes and mission partnerships through the diocese, which forms the particular Church. Parishes are called to be communities of solidarity. Catholic social teaching more than anything else insists that we are one family. We are one in Christ Jesus (cf. Gal 3:28) beyond our differences and boundaries.

Good ties between diocesan and parish efforts are indispensable. Parishes need to be bridge-builders, reminding us that we are part of a particular Church within the Universal Church with ties of faith and humanity to sisters and brothers all over the world.

It is envisioned that the institution of Diocesan Central Pool Funds (DCPF) will go a long way in our Diocese to make our Parishes, Mission Stations and Institutions self-sufficient in a foreseeable future. It is firmly hoped that all the Parishes and Priests will fully subscribe and support the above fund and thereby reduce the diocesan financial burden.

These revised norms come into effect on January 01, 2020.
